## TOWN OF PLYMOUTH ORDINANCE NO. 2022-02

AN ORDINANCE TO FILL THE OFFICES OF TOWN CLERK AND TOWN TREASURER BY APPOINTMENT PURSUANT TO WISCONSIN STATUTES SECTION 60.30(1e).

This Ordinance is adopted by the Town Board of the Town of Plymouth, Rock County, Wisconsin, pursuant to Section 60.30(1e) of the Wisconsin Statutes. The purpose of this Ordinance is to fill the offices of Town Clerk and Town Treasurer by appointment of the Town Board.

The Town Board of the Town of Plymouth, Rock County, Wisconsin, does hereby ordain as follows:

That, pursuant to Wis. Stat. § 60.30(1e)(a), the offices of Town Clerk and Town Treasurer shall be filled by appointment of a majority of the members-elect of the Town Board.

The term of the office for the appointed positions shall be set by the Town Board, but may not exceed 3 years per Wis. Stat. § 60.30(1e)(c). The Town Board may re-appoint the positions of Town Clerk and Town Treasurer for additional terms. However, removal by the Town Board during a given term of office may only be for "cause" as defined under Wis. Stat. § 17.001 and required by Wis. Stat. § 60.30(1e)(f).

This ordinance is subject to approval by the town electors in a referendum, which is hereby called by the Town Board to be held on November 15, 2022. The referendum question shall be:

"Shall the person holding the offices of Town Clerk and Town Treasurer in the Town of Plymouth be appointed by the Town Board?"

The salary of the appointed position shall be set by the Town Board and may not be reduced during the term of office.

This ordinance shall be in full force and effect from and after the date of its town board passage, notice after passage per Wis. Stat. § 60.80, and its referendum approval by the town electors as required by Wis. Stat. § 60.30(1e)(b).
